

# Presbytery of **Boston Council Minutes**

**Purpose, Date and Location of Meeting:** This Stated Meeting convened on May 16, 2019 online via Adobe Connect.

**Opening:** It being determined that a quorum was present, meeting was opened with prayer at 7:02pm by Mark Wells.

Adoption of Agenda and Approval of Minutes: It was moved and seconded to approve the agenda. *Approved.* It was moved and seconded to approve the minutes from the last meeting. *Approved.* 

#### **Report of Officers:**

**Treasurer-** Veronica spoke of the Budget Task Force. She said that all but one asked to serve had said "yes." She had one other to approach. Andy came online. He spoke to the Treasurer's Report. There were no questions. **It was moved and seconded to accept the Treasurer's Report.** Approved. TJ then asked Andy to attend the first meeting of the Task Force to help in an orientation. Andy said "of course he would."

**Moderator-** No Report

**Stated Clerk-** TJ spoke of a conversation with Cindy about the December Presbytery gathering at KCB, and about having Rev. Diane Moffett- the new chair of Presbyterian Missions- attend. Rev. Moffett said she couldn't make it on December 2<sup>nd</sup> (the currently scheduled date) but would be in the area December 9<sup>th</sup>. After a brief discussion, it was agreed to ask the Presbytery at the September meeting to move the December gathering to December 9<sup>th</sup>. He also reported that Presbytery minutes were approved by the Synod.

**Resource Presbyter-** Cindy was not present to give a report, but she sent one via email. There were no comments.

#### **Committees of Presbytery:**

Committee On Ministry (COM) — Eric reported that things are going fine, but he spoke of the need to begin a CRE training program. He said that COM would be bringing a proposal to council as to how to implement a CRE program. TJ asked for details about CRE training. Eric said that several seminaries offer CRE training programs for a reasonable fee. Eric said COM would be reaching out to them to see how to implement training here. Eric also spoke of a meeting with Andy regarding a Lynn Grant to the Cambridge church, and Cambridge's lack of a follow-up.

**Committee for Preparation for Ministry (CPM)** – Kristin reported that the committee met this week. They hoped to introduce a new inquirer at the next Presbytery gathering. She reported that a vacancy has occurred on CPM, and she hopes Nominating will come up with a candidate.

Congregations and Mission (C&M) – Katie reported that they are planning the June 8<sup>th</sup> Presbytery event. She said she hoped that each church could send a choir, and that each church could give a two-minute "testimony." She spoke of the difficulties of trying to meet as a "whole" committee, but said that "things are getting done." She also spoke of planning another "Clergy caucus."

**Trustees**- Sarah said that Trustees met last Saturday. Trustees are very concerned about the financial situation of the presbytery. There was a lengthy discussion of how the Fort Square funds are being used. It is their opinion that the Fort Square Task Force has not been dismissed, and they have yet to come up with a plan for the use of the Fort Square funds. There was a discussion as to the status of that Fort Square committee. It was suggested that TJ contact Beth Weimann about what decisions the Fort Square Fund committee had made. It was also suggested that Beth's committee be dissolved, and its function be transferred to the newly formed Budget Task Force. It was moved and seconded to recommend to the Presbytery to dissolve the original Fort Square Task Force. Approved. It was also moved and seconded that the members of the Fort Square Task Force be included in the Budget Task Force. Approved.

**Nominating Committee-** Dave Dorer gave a report. Nominating is searching for someone to serve as Vice-Moderator. He said they are also seeking two additional members for COM. He reminded everyone that both the chair and vice chair of COM are rotating off next year. TJ solicited suggestions for Vice-Moderator. Several names were put forward.

**Adjournment and Closing Prayer:** With the business of the meeting being concluded, **it was moved and seconded to adjourn.** Approved. The Meeting was adjourned at 8:00pm with a closing prayer from Ivy.
